FINDINGS, CONCLUSIONS

On January 5, 2016, Appellant Shawn Griggy filed with the Reclamation Commission a notice of appeal from a decision of the Division Chief, relating to coal mining permit D-2448, which permit is held by Rosebud Mining Company. This cause was assigned case number RC-16-002. On January 13, 2016, Rosebud Mining Company petitioned to intervene into this appeal.

On January 19, 2016, Appellant filed a *Notice of Withdrawal* of this appeal with the Reclamation Commission. Pursuant to Ohio Administrative Code §1513-3-17, case number RC-16-002 is hereby **DISMISSED** without further action required by the Reclamation Commission.




